

1PASSWORD PRODUCT-SPECIFIC TERMS

Customer's use of Trelica by 1Password ("**Trelica by 1Password**") Service is subject to these Product-Specific Terms and the governing agreement between Customer and 1Password referencing these terms (the "**Agreement**").¹ Terms not expressly defined herein have the meaning given in the Agreement.

Trelica by 1Password

1. Updated Definitions. When Customer uses Trelica by 1Password, the following definitions are added to the Agreement:

- a. **Customer Device** means any electronic device that processes data and communicates with the Platform, including browsers, personal computers, mobile and tablet devices, and servers, or other devices or terminal equipment supported by the Services.
- b. **Authorized User** any individual associated with the Customer who registers for an account and is granted access to use 1Password Device Trust. This includes employees, agents, contractors, or other personnel authorized by the Customer to access and utilize 1Password Device Trust on behalf of the Customer.
- c. **Integration Technology** means software applications and API's that allow for the integrating and enabling of communications between Customer Devices with the Services.
- d. **Managed Identity** means non-service account identities listed with an 'active' status in the Customer's primary identity provider (IdP) as integrated with the Services.

2. Non-Trelica Content and API Services. The Services may contain links to and content from third party websites, applications and services, and content actively made available by a third party using the Services itself ("Non-Trelica Content"). The Services may also contain the ability for the Customer to access, utilise or make changes to the Services from a third-party system or to a third-party system from the Service, made available by a third party through an API ("API Services"). API Services exclude any part of the Services that facilitates the connection to an API. The Customer agrees that:

- a. Non-Trelica Content is provided solely as a convenience on an 'as is, **where** is' basis;
- b. the Customer's use of Non-Trelica Content will be subject to any terms
